

Direct Cremation

The charge for direct cremation includes basic necessary authorizations, basic services of staff, removal of remains from a professional facility during normal business hours, local transportation to the crematory, and the crematory fee. This charge does not include the use of facilities for any viewing, public or private, prior to the cremation. State and local laws do not require a casket for direct cremations. If you want to arrange a direct cremation, you can use an alternative or cremation container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cherry, oak, poplar, pine, willow, veneer, fiberboard or cardboard. Alternative/cremation containers are not required by law but are requirements of the crematory. The minimum available is a cardboard container. A complete description of these containers is found under the heading "Cremation Containers." Our charge for a direct cremation ranges from \$1795 to \$8295.

Please note: If you choose to have a visitation/funeral service/memorial service, there are different and additional charges for these services. These charges include identification by photo (not in-person) and do not include the medical examiner's fee, any other cash advance other than the crematory fee, or the use of the facility for viewing or visitation. In Virginia, the fee charged by the medical examiner's office for approval is \$50; in Washington, D.C. it is \$75. The family room at the crematory may be available with a minimum of 24 hours notice for a family's viewing of the commencement of the cremation for \$495. For the return of cremated remains within 36 hours of the time of arrangement or conclusion of visitation/viewing/identification or service with the body present, please add \$200 in addition to any rush transportation arrangements that you may request.

To protect the health of our families and employees, in-person identifications are for identification purposes only and are not intended to serve as visitations or viewings. To minimize exposure, in-person identifications are limited to a maximum of five family members for fifteen minutes.

The Advent family provides these prices as a convenience to the family and for comparison purposes. The prices listed in this document and on our website may not reflect our most current price list, which may also be in the favor of families. Please always consult a licensed funeral director for the actual cost of a funeral.

Certain funeral services may be provided off-premises by other funeral service providers.

Basic Services of Funeral Director and Staff \$995.00
Our basic service charge includes, but is not limited to, staff to respond to initial request for service; conducting the arrangement conference with family or responsible party; preparation and filing of necessary permits and certificates; placement of up to two local obituary notices, planning service arrangements; coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding and receiving remains.)

Embalming \$575.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Please note: To protect the health of our employees and insure sanitary conditions, it is the policy of Advent Funeral and Cremation Services to (1) require the embalming or refrigeration of individuals whose burial or cremation will occur more than 24 hours from the time of death and (2) require embalming for individuals for whom an open casket visitation/viewing is selected.

Notice regarding vaults and/or liners: In most areas of the country, state and local law does not require that you buy a container to surround the casket in the grave. However, many cemeteries require that you have such a container so that the grave will not sink in. **Either a grave liner or a burial vault will satisfy these requirements.**

Forwarding Remains to Another Funeral Home

This charge includes necessary authorizations, minimum services of staff, use of preparation room, embalming, transfer of remains from professional facility during normal business hours, and local transportation to the airport (excludes shipping charges). This charge does not include visitation, rites or ceremonies prior to the forwarding of the body or casket/shipping container and is valid only for destinations within the continental United States.

Receiving Remains from Another Funeral Home

This charge includes the minimum services of staff, transportation from local airport, temporary shelter of remains, and hearse to a local cemetery. This charge does not include visitation, graveside services, church services, rites, ceremonies or outer burial containers.

Our charge for receiving remains from another funeral home \$1820

Direct or Immediate Burial

The charge for a direct burial (without rites, ceremonies, services, visitation, or in-person identification) includes basic services of staff, removal of remains from a professional facility during normal business hours, casketing and local transportation to the cemetery. This charge does not include bathing, dressing, the use of facilities and/or staff for any visitation or ceremony, public or private, prior to burial. Our charge for a direct burial ranges from \$2865 to \$8365.
